# Limited Licence Surrender: Licensed Technologist

## General

1. Before completing a request to surrender your limited licence, read the [Limited Licence and Certificate of Practice Guidelines for Surrender](#).
2. Allow approximately two weeks of processing time from the date of receipt of the request and any required documentation. An incomplete form may be returned for completion.
3. All sections of the form are to be completed. Use “Not Applicable” and “N/A” where sections do not apply.
4. Submit the surrender request form to [officeoftheregistrar@oaa.on.ca](mailto:officeoftheregistrar@oaa.on.ca). All documentation submitted will be verified.

## Regulatory Information

From the *Architects Act* of Ontario:

“architectural services” means services that are part of or are related to the practice of architecture

“design” means a plan, sketch, drawing, graphic representation, or specification intended to govern the construction, enlargement, or alteration of a building or a part of a building

“practice of architecture” means,

- (a) the preparation or provision of a design to govern the construction, enlargement, or alteration of a building,
- (b) evaluating, advising on or reporting on the construction, enlargement, or alteration of a building, or
- (c) a general review of the construction, enlargement, or alteration of a building

### Membership

5. (1) Every holder of a licence or limited licence is a member of the Association, subject to any term, condition, or limitation to which the licence is subject.

### Resignation of membership

(2) A member may resign [their] membership by filing with the Registrar [their] resignation in writing and the member’s licence or limited licence is thereupon cancelled, subject to the continuing jurisdiction of the Association in respect of any disciplinary action arising out of [their] professional conduct while a member.





**C. SURRENDER REQUEST**

I, \_\_\_\_\_ (type or print full name), hereby request that the OAA accept the resignation of my membership and the surrender of my limited licence (and, if applicable, my certificate of practice) under the *Architects Act* effective as of the date above.

In making this request I confirm the following:

- 1 I understand that upon surrender of my limited licence I must immediately cease use of the designation “OAA” after my name and cease use of the title “Licensed Technologist” with respect to the practice of architecture.
- 2 I understand that if I held an OAA-issued seal, I must return it to the Office of the Registrar and remove any scanned or digital images of it from my computer system or other locations.
- 3 I will notify my employer (if applicable) that I am no longer a licensed member of the OAA and ensure that any promotional materials, professional cards, letterhead, website, or other signage that contain “Licensed Technologist” or “OAA” will be discontinued.
- 4 If I am currently providing architectural services under a certificate of practice, I have made arrangements for completion or transfer of those services to another holder of a certificate of practice, and I have notified all clients, consultants, contractors and relevant authorities (including building permit holders).
- 5 I understand that if I wish to re-apply for a limited licence in the future, specific rules apply:
  - If within three years of surrender, I am exempted from the academic, examination, and experience requirements of Section 32 of Regulation 27.
  - If more than three years have passed, the full academic, examination, and experience requirements apply.
- 6 I understand any outstanding fees, premiums, levies, or deductibles owing to the OAA must be paid.

**D. CHANGE IN STATUS**

- 3 I understand that surrendering my limited licence does not absolve me from any obligations, liabilities, or ongoing matters arising from my professional practice while I was licensed, including complaints, investigations, or outstanding fees.
- 4 I confirm that all statements made in this request are true and complete to the best of my knowledge.
- 5 I understand that once my limited licence is surrendered, reinstatement will require compliance with any applicable OAA policies or statutory requirements for re-licensing.
